1) Presentation of the Meeting members, constitution and licence verification;

The Chairwomen, Mrs. Patrizia La Delfa, after the presentation of each member, declares the constitution of the College Members. The licenses have already been verified by the Secretary and are all valid.

2) Welcome by the Organization's Representative

Mr. Giovanni Cuccioloni, President of the Organization's Committee, welcomes all the present members and will be available for any need.

3) Approval and posting of the meeting calendar / presence of the Stewards of the Meeting;
Presentation of the event by the Clerk of the Course and the route set-up delegate about the technical, operative and safety plan of the route set-up.

The Meeting Calendar is approved and the Secretary is advised to poste copy of the communication (doc. 2.1.) on

the Official Notice Board.

The Clerk of the Course, Mr. Fabrizio Bernetti, illustrates the event and highlights in detail the safety measurements put in place. In particular, seen the last regulations given by the Sport Council, in agreement with the Safety Inspector, Mr. Oronzo Pezzolla, communicates that a new chicane will be placed.







Therefore a new information bulletin is raised (Bulletin 2 FIA doc 1.2. – Bulletin 3 ACI doc 1.3), which will become integrative part of the Safety Plan, already approved, and notified to the Competitors during the Administrative Checks.

He also informs that 216 Competitors/Drivers are registered to the event and 32 of these will participate in IHC.

4) Examination of the race's documentation RPG, authorization, assurance

The RPG is checked (FIA visa nr. 2IHC.ITA.11.05.2022 – approval ACI RM/016/2022 dated 11.04.2022), also the assurance policy and the administrative documents, all are in conformity.

5) Eventual information bulletins, considerations and approvals;

The information bulletins nr. 1 - FIA (doc. 1.1) and nr. 1 and 2 - ACI (doc. 1.1. and 1.2) are checked and are validated by FIA and by ACI Sport DSA

6) Eventual instructions for the pre-race Scrutineering.

Even if the Covid protocol validity is expired yesterday, 23rd June 2022, the pre-race Scrutineering will be carried out following the same protocol criteria and RPG approved.

7) Report of the Competitors' Relation Officer:

The Competitors' Relation Officers show their program and presences, posted at the Official Notice Board

8) Any other business

Mr. Rosario Giordano, press release responsible for Aci Sport and CIVM coordinator, explains the modalities with which ACI Sport will promote the event through the TV channels and live in streaming. At 10.00 the meeting is closed and updated as scheduled.

9) Report of the Clerk of the Course about the pre-race administrative checks;

The Clerk of the Course informs that the administrative checks have been carried out regularly with the following results (doc. 3.4):

IHC entered 28 checked 25

- CIVM/TIVM entered 203 checked 194

The Competitors/Drivers not showed up, justified their absence. The Competitors/Drivers nr. 54-44-37-1 have declared during the administrative checks to not participate in race IHC, but only for the Italian title;

10) Report of the Scrutineers about the pre-race Scrutineering;

The FIA Technical Scrutineer, Mr. Kleinschmidt, communicates (doc. 4.1) to have checked nr. 25 cars, all in conformity and belonging to the declared groups during the registration (the PF variations are not causing group changes). The car nr. 98 has not shown up at the pre-race Scrutineering and will therefore not be admitted to the race IHC.

He has also submitted the Scrutineering proposal to be carried out during the practices (doc. 4.2), that the Stewards of the Panel approve.

The ACI Technical Scrutineers, Mr. Guarino and Mr. Zanotti, communicate (doc. 6.1) to have checked nr. 194 cars, all in conformity, and highlight the following group changes:

Nr. 263 from Twin-cylindrical/700 Gr. 2 to historic 2/H1/T 700

Nr. 248 from ProdEvo/1.4

to Racing Start/RS2.0

Nr. 51 from GT/Supercup

to GT/Cup

11) Report of the Competitors' Relation Officer

12) Examination of the verified and admitted starting list to the official practices, presented by the Clerk of the Course;

The Clark of the Course presents the list of the checked competitors/drivers and the admitted ones to the first official practice (doc 5.2) and to the second official practice (doc 5.3), that will be posted on the Official Notice Board.

14) Report by the Clerk of the Course about the official practices

The Clerk of the Course confirms that the official practices were carried out regularly (doc. 3.5), without important accidents. All the Drivers started at least one session of the practices or are classified in one of the previous editions, excluding nr. 302 - 196 - 44 - 24 for which he proposes the admission to the starting order of the race. With decision nr. 1 (ACI doc 2.2) the Panel authorizes the admission.

15) Report by the Competitors' Relations Officer;

Nothing to declare.

16) Examination and approval of the Starting Order List of the Races;

The Clerk of the Course presents the Starting Order List – Race 1 (doc. 5.4) and Race 2 (doc 5.5), which will be posted at the Official Notice Board, as scheduled.

17) Technical Scrutineering at the end of the Races.

The Technical Scrutineers give to the Stewards the proposal for the Scrutineering to be done during and after the race.

18) Any other business

After checking the report of FIA delegate Technical Scrutineer about the scrutineering done during the practices (doc. 4.3), informing about the non compliance of the car nr. 52 (Competitor SC. AB Motorsport/Driver Peruggini Lucio) in particular about the weight (lower than previewed by the PF Technical Sheet), the Panel invites the Competitor/Driver (FIA doc. 2.2). After the interview with the Driver Peruggini Lucio, who represents the Competitor with the specific delegation, the Panel decides to apply a fine of Euro 250,00 which is suspended until the end of the season 2022, because it is the first occurrence of this infringement, unless the same is committed again (FIA doc. 2.3).

It is specified that for ACI Sport Technical Regulation the car is in conformity, therefore no measures will be taken. The Driver declares, furthermore, that he doesn't want to participate in race IHC, but he wants to appear exclusively in the classification valid for the Italian title.

At 19.30, having nothing else to be discussed, the meeting is closed and updated as scheduled.

--4th MEETING---

At 18.00 of the 26th of June 2022 the meeting starts again as scheduled

19) Eventual measures adopted during the race;

Following the report of the Technical Scrutineers about the behavior of the Competitors/Drivers nr. 107 (Loffredo Giovanni) and 109 (Nappi Pietro) during the Technical Scrutineering, at the end of Race 1, the Panel decided to call both before starting Race 2 (ACI doc. 2.3 and 2.4), and they explained the reason of their behavior and for which they apologize.

The Panel, given their good faith, while considering the reasons understandable, but not justifying the behavior, decides to impose both the sanction of "beware warning" (ACI doc. 2.4 and 2.5)

20) Report by the Clerk of the Course about the Races.

The Clerk of the Course informs that the race started on time at 09.00 and ended at 17.45. Some stops are declared, but without important accidents.

21) Report by the Competitors' Relations Officer;

Nothing to declare.

22) Examination of the final classification submitted by the Clerk of the Course;

The final classifications are posted at 17.40 for the IHC and at 17.40 for the CIVM/TIVM.

23) Eventual claims.

No claims are raised.

24) Report of the Technical Scrutinees about the Scrutineering after the Race.

All the checked cars are in compliance (FIA doc. 4.5-ACI doc. 6.3)

The ACI Technical Scrutineers informs that they have not been able to check after race 2 the cars nr. 238 – 248 – 253, because they were without the necessary documents.

The Panel, having received this declaration after the opening of "parc fermé", without the possibility to invite personally the Competitors/Drivers, provides the notification through the Official Notice Board (and following to be

sent through a certified mail by the Organization the decision of excluding from the classification of Race 2 of TIVM the following Competitors/Drivers nr.

- 248 GIUSEPPETTI Mirko with decision nr. 5 (ACI doc 2.8)
- 253 LORENZINI Rodolfo with decision nr. 6 (ACI doc 2.9)

25) Approval of the final classifications

The Classifications FIA IHC are approved, while the classifications ACI, are approved at 20.20, after the correction.

26) Authorization to open the parc fermé

The Clerk of the Course is authorized to open the parc fermé.

27) Prize award ceremony

The prize award ceremony takes place at the parc fermé, as scheduled.

28) Any other business

Nothing to declare.

29) Reading and approval of the Stewards' minutes and closing of the event.

At 20.30 the minutes are read and approved. The Chairwoman thanks everybody for the cooperation and declares the event closed.
