### RULES FOR PRESS ACCREDITATION

Journalists, photojournalists, cameramen and radio operators must show an original copy of the request for accreditation formulated by a journalistic or telematic organization registered with the court of territorial jurisdiction. Each applicant for press accreditation must show the request for accreditation on the headed paper of the entity they represent or document that they belong to them. Acceptance of the accreditation application is subject to the endorsement of the press office of the organizer of the event. Each request will be verified so that the real conditions exist for the issue of accreditation and, where required, subject to the supervision of the competent National Sports Federation or higher Organ.

For organizational and security reasons, each newspaper, agency and / or photographic or video studio can credit a maximum number of 2 correspondent. Any other request will not be accepted except in cases deemed suitable by the press office.

**Press accreditation is issued exclusively to people over 18 years old. The pass delivered by the Press Office is strictly personal and the transfer to third parties is strictly forbidden. Any abuse, if detected, will be reported to the competent authorities.**

### DECLARATION OF RESPONSIBILITY

The undersigned declares to be aware of the dangers that may exist in the context of car events and to assist in their development along the race course. Also declares to have the experience and professional preparation to assist, safely, in carrying out them and that he undertakes to take all necessary precautions to avoid physical and material damage to himself and to others; to comply with the safety orders issued by the Race Officials and the Police; to assume any and all responsibility for damages that he should suffer, due to his own imprudence or inexperience. To release the Organizing Committee, the Race director and any other person, Institution or Association from any and all civil and criminal liability as far as the above extended. The undersigned also undertakes to observe any provisions relating to the use and validity of the pass, possibly communicated by the Press Office.
