PRESS ACCREDITATION REGULATIONS

- ▣ Journalists, photojournalists, video operators (including Freelancers), and radio operators must present an original copy of the accreditation request issued by a print or digital media outlet registered with the competent local court.
- ▣ Every applicant for press accreditation must present the request on the official letterhead of the entity they represent or provide documentation proving their affiliation with it.
- ▣ The acceptance of the accreditation application is subject to approval by the event organizer's press office.
- ▣ Each request will be verified to ensure the actual conditions for issuing the accreditation are met and, where required, subjected to the supervision of the competent National Sports Federation or higher body.
- ▣ For organizational and safety reasons, each media outlet, agency, and/or photo or video studio may accredit a maximum number of 2 representatives. Any other request cannot be accepted except for cases deemed appropriate by the press office.
- ▣ **Press accreditation is issued exclusively to individuals over 18 years of age. The pass delivered by the Press Room is strictly personal, and transferring it to third parties is severely prohibited. Any abuse, if detected, will be reported to the competent authorities.**

DECLARATION OF LIABILITY

The undersigned declares to be aware of the dangers inherent in motorsport events and in watching them along the race track. The undersigned also declares to possess the experience and professional training to safely attend the event and undertakes to take all necessary precautions to avoid physical and material damage to themselves and others; to respect the safety orders issued by the Race Officials and Law Enforcement; to assume any and all liability for damages they may suffer due to their own imprudence or lack of skill. Furthermore, the undersigned releases the Organizing Committee, the Clerk of the Course (Race Director), and any other person, Institution, or Association from any and all civil and criminal liability regarding the aforementioned. The undersigned also undertakes to comply with any regulations regarding the use and validity of the pass that may be communicated by the Press Office.
